Additional Information

We offer a 15-minute grace period, but after that, entry is at the discretion of our door staff, and seating may not be guaranteed.

We won't seat your party until everyone has arrived. Once seated, parties of up to four guests have a reserved table for 2 hours, while parties of five or more get 2 hours and 30 minutes. If you exceed your reservation time, we may suggest moving to the bar area.

If you have allergies, please notify your server before ordering. While we take precautions, we can't guarantee there's no risk of cross-contamination.

Our restaurants provide a mature adult setting, not recommended for children. Guests under 21 should conclude their visit by 9 PM.

Management reserves the right to refuse service to intoxicated or inappropriately dressed patrons. Outside food and beverages are not permitted.

Only service animals specially trained and covered under ADA are allowed.

For privacy and consideration of other guests, professional cameras, lighting, or equipment are not allowed.

Dining Quidelines

CHILDREN

PAYMENT PREFERENCE

We like to keep it easy for you. We accept cash payment as well as most major card methods and accept Visa, MasterCard, and American Express.

GROUP SIZE

Our restaurant is designed for smaller gatherings. Tables are cozy, perfect for up to four or six folks, depending on the size. Separate reservations aiming to create larger parties won't be accommodated. If you're looking for a larger group, maybe our Private Dining Room would suit you.

PRIVATE DINING

To make a real statement with your large crew, our private dining room can seat around 20 folks. It's separated from the main room, perfect for your event. You'll have your own space to do your thing, away from the rest of the crowd.

CORKAGE/ DESSERT FEE

Our restaurant observes a corkage fee of \$35 per bottle. If you would like to bring a cake to celebrate your occasion, you are more than welcome to. Our restaurant observes a \$5 per slice cake cutting fee.
